

# **TEMPLATE RELATING TO THE SUBMISSION OF A REASONED REQUEST PURSUANT TO ARTICLE 10 OF REGULATION (EU) 2022/1925 (Digital Markets Act)**

## **INTRODUCTION**

Pursuant to Article 10(1) of Regulation (EU) 2022/1925 of the European Parliament and of the Council of 14 September 2022 on contestable and fair markets in the digital sector (Digital Markets Act),<sup>2</sup> a gatekeeper may request to be exempted, in whole or in part, from a specific obligation laid down in Articles 5, 6 or 7 in relation to a core platform service listed in the designation decision pursuant to Article 3(9), where such exemption is justified on grounds of public health or public security.

This template specifies the information that the Commission needs when assessing a reasoned request submitted by a gatekeeper pursuant to Article 10 of that Regulation.

## **SECTION 1**

### **Contact information of the undertaking submitting the reasoned request**

    - 1.1.2.2. if one or more authorised external representatives of the Undertaking are appointed, the name, address, telephone number and e-mail address of, and position held by, each such representative to whom documents may be served. Provide also the original written Power of Attorney for such representative(s) (based on the model Power of Attorney available on the Commission's website<sup>3</sup>).

Describe how a full or partial exemption from the obligation may impact the Undertaking's compliance with any other obligation laid down in Articles 5, 6 and 7 of Regulation (EU) 2022/1925 in relation to the core platform service concerned by the request for exemption and which, according to Article 8(1) of that Regulation, should be effective in achieving the Regulation's objectives.
- 2.8. Describe the measures, if any, that the Undertaking will take to mitigate the effect of an exemption from the relevant obligation (or part thereof).
- 2.9. Should the Undertaking consider that the exemption from the obligation (or part thereof) listed under Section 2.1 is urgent and request the Commission to provisionally suspend the application of such obligation under Article 10(4) of Regulation (EU) 2022/1925, please provide a substantiated motivation as well as any supporting information, including any internal documents prepared in this regard.
